

**DUET Choreography - Fusion Studios Dance Company/High School Team  
AGREEMENT**

This agreement states that I (PARENT 1) \_\_\_\_\_ and (PARENT 2) \_\_\_\_\_ agree that (CHOREOGRAPHER) \_\_\_\_\_ will be instructing (STUDENT 1) \_\_\_\_\_ and (STUDENT 2) \_\_\_\_\_ with duet Choreography for the 2023-2024 Fusion Studios Dance Season. The term of this agreement commences on or before October 1st, 2023, ending on the date of the last duet performance.

STUDENTS/PARENTS shall make payment to CHOREOGRAPHER as fees for CHOREOGRAPHIC SERVICES in accordance with the following:

- \$450.00 for choreography. This does not include private lessons with CHOREOGRAPHER in the STUDIO and does not include studio rental fee. (A deposit of \$225 must be made upon signing and turning in the contract. If PARENT ½ and STUDENT ½ back out of contract before October 1st, 2023, \$112.50 will be returned to PARENT ½ and STUDENT ½.)
- Each rehearsal is \$66.00 per hour and will be paid **BEFORE THE REHEARSAL BEGINS**. STUDENTS are required to rehearse with CHOREOGRAPHER in STUDIO for 2 hours a month (October-May/June) and can be broken up however the teacher and students deem fit.
- If you choose to start your piece before the required time (October 1st), you are still required to fulfill the 2 hour per month minimum requirement starting in October.
- STUDENT and PARENT are responsible for meeting their 2 hour per month minimum rehearsal requirement. If your CHOREOGRAPHER is unable to rehearse for any reason, then it is the parent's responsibility to obtain another rehearsal with an available teacher at the studio. If your 2 hour monthly requirement is not met during a month, then the missed time needs to be made up in the following month. If the 2 hour requirement is not met over a period of 2 months then you will not be able to compete your routine until the rule is met.
- No rehearsals will be given if payment isn't received PRIOR to the start of rehearsal. NO EXCEPTIONS!
- If STUDENTS/PARENTS cancel a scheduled private within 24 hours of the rehearsal, the STUDENTS/PARENTS must still pay the CHOREOGRAPHER for scheduled private. Rental fees will be waived.
- Dancers attend ALL competitions the studio attends. Nationals are optional. (Unless on a High School Team and there is a conflict with a High School Event.)
- STUDIO room rental fees are \$20.00 per hour and will be auto-charged on the 20th of each month through FUSION STUDIOS.

PARENTS AND STUDENTS covenants and agrees with the CHOREOGRAPHER as follows:

- STUDENTS/PARENTS must get approval from CHOREOGRAPHER for rehearsals with other Teachers. (This only applies in regards to the solo choreography. Any choreographic suggestions by another teacher must be presented to and approved by the original choreographer.)
- Use of STUDIO is based on availability and is nonexclusive (PARENT may enter STUDIO to videotape at the end of the rehearsal if the teacher permits). STUDENTS may be relocated to another room depending upon STUDIO needs.
- All videotaping must remain solely for the purpose of practicing, until after the first competition.
- CHOREOGRAPHER has final say on all artistic decisions, with the best intentions for the dancers, including costume, song, staging, choreography, etc.
- The placement/level the dancer will compete is at the Studio Owner's discretion. There will be no discussion of changing levels.
- Fusion Studios staff is not responsible for running/rehearsing your routine at dance competitions. Please coordinate with your CHOREOGRAPHER to learn what is expected of you at competition as far as running your own routine.
- No questions/concerns regarding the above UNLESS the concern is regarding appropriateness or physical safety. PARENT must then schedule an appointment with CHOREOGRAPHER at a mutually convenient time or send an email to discuss any questions or concerns. **No discussion through text or phone calls.**
- CHOREOGRAPHER will discuss competition judging critiques and scores with STUDENT ONLY. PARENTS may request critiques and scores by email.
- STUDENTS can lose their duet privileges if class requirements are not fulfilled, delinquent payments occur, or misconduct.

Fusion Studios' Owner, SANDRA BARRANCO, reserves the right to withdraw this duet routine for any plausible reason, including violation of this contract. By signing this document you agree you have read the terms and conditions of this contract, you understand them, and agree to comply with this contract.
